
Madam/Sir,

With reference to KVS(HQ), New Delhi letter No F.6-1/2017/KVS(HQ)/EDP/DC/Video Conference dated 02-03-2017 on the subject cited **interaction of Commissioner, KVS with Deputy Commissioner of Regional Offices**". It is to inform you that Video conference was held on 06th March 2017 for Online Admission of class-I and the following points were discussed:

1. All Vidyalayas, where Registration of candidates is very low, should take necessary steps to enhance number of registrations as last date of admission is very close specially Kendriya Vidyalaya Leh, Kargil, Nubra, Humhama, Bandipur, Pahalgam, Anantnag, Chenani, Aminoo(Kulgam), No 1 & 2 Chamera and Bakloh **needs urgent attention in this regards.**
2. All Principals are requested to compare number of registrations for admission in class I made this year with last year registration and ensure that there should be minimum variation in this regard.
3. All Principals are also requested to intimate about complaint received from any stake holders and suggestion received from the Chairman VMC, if any, regarding Online admission.
4. Offline Registrations other than admission under special provision, if any, should be made online before last date of registration. KV Humhama, Leh, Nubra needs urgent attention in this regards.
5. It is expected that there are some discrepancies in the applications of registered candidates. Please ensure about complete and correct information of registered candidates, if any discrepancy noticed, the same may be communicated to concerned parents with the instructions to submit correct information by using their user ID & password.
6. Short listing, verification and final admission list will be prepared at Vidyalaya level through KV Shaala software.
7. Draw of lot for RTE admission will be done on 18th March 2017 at 11.00am as communicated in the Registration form. Hence, the composition of committee as per Para 5 of Part 'C' of Guidelines for admissions in Kendriya Vidyalayas (2017-18)' for draw of lots should be notified with the concurrence of the Chairman VMC at least five days in advance for draw of lot.
8. It is expected that Vidyalaya Master has been updated by all the Vidyalayas. However, it is requested to check specially **Type of Vidyalaya, No. of Sections sanctioned for 2017-18 and NO of shifts.** If any discrepancy noticed, please update it on 13th & 14th March 2017 as the portal will be open for updation by MGRM.
9. All Principals, wherever online registration is not possible because of non availability of internet in the vicinity, are directed to establish facilitation centre in the own KV or nearest KV/NIC where internet facility is available for parents so that they can register their applications online before 12th March 2017.
